We believe in a safe, healthy and energy-efficient home for everyone and perform critical repairs, modifications and rehabilitation on the homes and non-profit facilities of low-income families with children, military veterans, the elderly and people with disabilities.

## **Position Description:**

The Safe & Healthy Homes Coordinator will work directly with clients from our various programs and assist in coordinating all aspects of programs including Flexible Services Programs (Asthma, Asthma Repairs, and Nutrition Rx), #GreenNFit volunteer projects, HUD Healthy Homes, and Veterans Grants. These clients and homeowners are in need of a healthy home assessment, "prescription" of supplies such as HEPA Vacuums, air purifiers, etc., coordination with contractors, and supply delivery. This position is a hybrid remote/in office/on site position. It does require travel mostly around Hampden county but may include the entire Pioneer Valley and occasional weekend/evening hours.

#### **Project Management**

- Perform approximately 5-10 home visits per month to provide one on one education sessions covering methods to improve and maintain the health, safety, and energy efficiency of clients' homes and developing long-term home maintenance plans
- Maintain production schedules as defined by funding contracts, regulations, and agency directives
- Prepare individual client assessments and client action plans
- Maintain detailed and concise records of family meetings using RCDC's data collection system called Efforts-to-Outcomes
- Report data in compliance with standards and regulations and assist management in regular program reporting
- Complete all site inspections with program manager and oversee the volunteer workday teams
- Assist in volunteer projects as needed, including coordinating construction materials and oversee workday logistics
- Coordinates purchases and follow up construction work
- Maintains inventory of tools, supplies, materials and equipment located in storage unit; distributes materials, equipment, inkind donations and supplies as needed
- Inspects and assesses homes before and after projects to ensure thoroughness and completion
- Complete and performs follow-up home repairs, project oversight including in-progress and final quality control inspections
- Participate in weekly and other team meetings as appropriate
- Regularly update and enhance RCDC's resident education curriculum and training modules on Healthy Housing, energy efficiency and other home-based environmental health issues using the most up to date environmental research and knowledge
- Conduct RCDC trainings to health and housing professionals, community-based organizations, property owners, parents, and community residents
- Provide outreach to low-income and diverse communities through representation at meetings, health fairs, and other events;
- Support broad mission and policy efforts and initiatives of RCDC; other duties as assigned related to organizational mission.
- Maintain appropriate records, i.e. lead tests, subcontractor insurance and license information

### Qualifications

- Proficient with Microsoft Office Suite and data collection, capture and tracking methods.
- Ability to organize and maintain appropriate records and documentation.
